ADOPTER AGREEMENT

The following terms and conditions constitute a contract for the adoption of the dog described above (hereafter referred to as "Xoloitzcuintle" or "dog" regardless of age or sex) between Xoloitzcuintle Rescue USA (XRUSA) and the adopter.

These terms and conditions are entered into and agreed upon by both XRUSA and the adopter acknowledging the moral and legal worth of this contract.

I/we, the undersigned agree to all of the following terms of this contract and understand that non-compliance with the terms of this agreement gives XRUSA the right to reclaim this Xoloitzcuintle without refund of adoption fee. Adoption fee is accepted in the amount of: \$_____, payable to XRUSA (please note: no private checks should be written to any XRUSA member for adoption fee. Exceptions are fees not previously paid by XRUSA to a member for crates and/or transport if applicable).

Please Initial if in agreement:

1	In the event I am no longer able to care for this Xoloitzcuintle, I agree to notify XRUSA immediately to arrange for the dog to be returned to a XRUSA member.	
2	To notify a XRUSA member immediately if this Xoloitzcuintle is lost, or stolen and to make every effort to locate the Xoloitzcuintle	
3	To <u>NEVER</u> take this Xoloitzcuintle to an animal shelter, pound or humane society.	
4	To <u>NEVER</u> allow this Xoloitzcuintle to be used in animal research.	
5	To always treat this Xoloitzcuintle as a family pet, with affection, kindness and not subject this Xoloitzcuintle to abuse or cruelty at any time.	
6	To provide regular veterinary care, including annual vaccinations, parasite checks and dental care as determined by your veterinarian.	
7	To provide proper food, shelter, fresh water, adequate companionship at all times and to keep this dog in a securely fenced area. Proper shelter means this Xoloitzcuintle is to be a family companion. Under no circumstances is the dog to be a "yard dog". At no time is the dog to be tied or chained to a stake, line, or structure for the purpose of exercise or elimination. Electronic/underground/invisible fencing is not permitted as the sole means of providing security for the dog.

8	To not transport this Xoloitzcuintle in an open vehicle or in any way endanger the dog in transportation.	
9	To immediately license, and place identification on the dog.	
10	To notify an XRUSA member if I move and provide the new address and phone number.	
11	Under no circumstance, sell the adopted Xoloitzcuintle to pet dealers, pet stores, puppy mills, or benefit financially from this dog.	
12	To not kennel this Xoloitzcuintle, except to provide for safety (i.e. when absent from the home and he/she is alone, transporting, or to sleep at night).	
13	The above Xoloitzcuintle will not be euthanized in a non-emergency situation without notifying XRUSA by registered letter and giving 14 days to respond.	
14	The adopter agrees to allow an XRUSA member to periodically check on this Xoloitzcuintle to be assured of compliance with items #1 through #15.	
15	I agree to notify the XRUSA member on the above dog's progress after I have owned the dog for one month, three months, and the first year mark.	

ENFORCEMENT OF CONTRACT

Any breach of this contract in part or whole requires that the adopter return the Xoloitzcuintle to a XRUSA member at the adopter's expense without entitlement of any refund or damages of any kind.

If the Adopter fails to meet ANY of the articles listed under "Adopter Agreement", an XRUSA member reserves the right to repossess the Xoloitzcuintle and any papers that pertain to this Xoloitzcuintle. No compensation will be due adopter at the time of the repossession. Violation of ANY provisions of this

contract will constitute damage to the reputation of XRUSA, and the Adopter agrees to relinquish ownership of the Xoloitzcuintle, shipping the dog to a XRUSA member, absorbing all costs of any related court activity.

The undersigned adopter(s) has been advised of these facts and agrees to accept all responsibility for the behavior of the Xoloitzcuintle chosen for adoption, and agrees to all conditions of this contract.

RELEASE OF LIABILITY AND INDEMNIFICATION:

In consideration of Xoloitzcuintle Rescue USA allowing me/us to adopt this Xoloitzcuintle as our pet, I/we promise and agree to be solely responsible for this animal and to indemnify and hold harmless XRUSA, and any XRUSA members from any and all claims of liability for the conduct of this Xoloitzcuintle on or after the date of this adoption and agreement of contract.

I/we do agree to the above terms and provisions for the specific Xoloitzcuintle on this contract. Furthermore I/we do hereby release and forever discharge Xoloitzcuintle Rescue USA, and any XRUSA member, and any other person, heirs, and assignees from any and all liability, claims, demands, expenses, damages, causes of action, compensation, and for personal injury and property damage arising from and resulting from the acquisition of the above referenced Xoloitzcuintle, both known and unknown which I have now or may have in the future. I/we also agree that the initials in #1-15 above is my (our) initial(s).
